# 4319 Lower Recreation Ground

Members to report back on quotes for the boundary fence, repositioning and removal of the ham stones and cleaning and repainting the play equipment. Initial enquiries into MUGA for the upper rec have indicated costs will be in the region of £45,000. Two further quotes are being sought for the fencing. Councillors have cleaned the lower rec equipment and will be organising a group to paint/stain equipment as necessary in September.
