- 21/01786/FUL Land Adjoining Church Street Application permitted with conditions

Cllrs and County Councillor Sue Osborne were disappointed that this planning application didn't go to full committee. The objections raised by the council were as follows;

- a) the pavement subsumes not just the verge but part of the highway leading to a reduction in road width. The highway in this section of Church Street (part of the B3162) is already narrow and has a blind junction (Court Street) opposite the development and a blind bend in close proximity. NPPF111
- b) if the highway is maintained at the current width the stated sightlines for the access will be altered.
- c) The highways report indicated that the right turn sightline was missing from the application. This needs to be included but will also be altered.
- d) Is it within the developer's authority to build part of the development on highways property?
