0224 Lower Recreation Ground

Working Party to report back on their progress. Their main priority is the fence for which further quotes need to be obtained. A general clean up and tidy up is required. Fortnightly Risk assessments of the play area and equipment will now be carried out by Cllr Adams. The logs and the safety surface are the next two items that should be done. Cllr Weller offered to repaint the equipment at the cost of materials only. **Action:** Clerk to obtain quotes for cleaning the safety surfacing before the next meeting and to revisit the quote for the logs.

0225 Members to consider the following requests from Winsham Recreational Trust

- b) The Parish Council approve the installation of patio doors in the Upper Recreation Ground Clubhouse **Resolved:** Members approved the installation of patio doors as this would also provide a much-needed accessible entrance **Proposed** Cllr Everard **Seconded** Cllr Adams **Vote**: 9-0-0
 - c) To discuss the roadway connecting Bakersfield and the Upper Recreation Ground

Action: Chairman to investigate who owns the entrance to the upper rec and the cost of repair/resurfacing

0226 Items for Report

- Cemetery and Churchyard **Action:** Clerk to investigate the cost of suitable grave markers to help identify new plots. A lot of soil has been placed on the compost heap in the cemetery. **Action:** Cllr

Fowler to speak to Mervyn Powell about separating the area into three bays. A number of grave stones have been collapsed in the cemetery. **Action:** Cllr Everard to investigate. It was reported that it has been difficult to find relatives of the graves where the memorial stones are in need of repair.

- ◆ Bus Shelter Nothing to report
- War Memorial We have been advised that work on the base will start on 19th June. A Section 171
 has been applied for from Highways.
- Seating, Signage and Bins Enquiries have been received as to when the seat will be fitted in Ebben Lane. This will hopefully be fitted before the end of June
- ◆ Telephone Box This is still being well used
- Allotments Allotment 6 has been allocated. It was agreed that no rent will be charged for the first year because it is such a state.
- b) Defibrillator Pads have been ordered and arrived, Cllr Everard will fit these after the meeting
- c) Web Sites Nothing to report
- d) Public Rights of Way Cllr Harding reported that where the footpath goes up to Broadenham from Court Lane there is a gate that has entirely come off its hinges where the path enters the woods.
- e) Grass Cutting Report First three cuts have been done and everything looks really good
- f) Gardening Group Cllr Vickers is a member of the group
- g) Environmental Issues A report has been received that a wheel with tyre has been left along the B3162 in the layby down from Street Farm. Also, a second tyre has been left on Whatley Lane between Whatley Crossroads and Leigh. These have been reported to Highways by ClIr Beentje.
- h) Highways and Bus Services £2 bus fares are still running. Catch the bus campaign will be running again at the next coffee morning in the Jubilee Hall

- Winsham Recreational Trust There are on-going minor improvements, we have talked about the lease and looking into the constitution. A lot of events are coming up including a children's Lego club, Yoga, Rockin Ronnie, Jorden Lindsay, Bingo, charity fund raising events, dog show, and the annual fun day. Newsletter due to go out in the next few days. Concerns were raised regarding the grant that was usually provided by Somerset County Council which cannot be guaranteed by the new Somerset Council. They have also had a recent enquiry for a youth football team.
