Their observations and recommendations to be brought to future meetings for approval by full council.

- e) Members of Winsham Parish Council and Trustees of Winsham Playing Fields Trust to attend a Training Event (Parish Councils, Village Halls, and Recreation Grounds – understanding the differences and how they can support each other), being held on 26th September at Long Sutton Village Hall by the Community Council for Somerset and to approve payment.

Once the quote is received, the Clerk will then contact the Insurance Company for a revised premium, which will then be brought back to a future meeting for consideration.
